

**BOARD RESOLUTION OF  
THRIVE CENTER FOR SUCCESS  
REGARDING CYPRESS CAMPUS APPLICATION WINDOW  
AND LOTTERY DATES**

**WHEREAS**, Thrive With Autism, open-enrollment charter holder for Thrive Center for Success (CDN: 170802), is opening a second charter school campus, as contemplated and authorized by the charter contract; and

**WHEREAS**, the second campus, Thrive Center for Success - Cypress (170802-003), is scheduled to open in August 2026; and

**WHEREAS**, the Thrive Center for Success open-enrollment charter contemplates that the Superintendent or designee shall set a beginning and closing date for the application window for each school year; and

**WHEREAS**, Thrive Center for Success - Cypress was assigned its campus number by the Texas Education Agency (“TEA”) on March 31, 2026, after the open-enrollment end date established in Board Policy PG-3.201 had passed; and

**WHEREAS**, the facilities lease agreement for Thrive Center for Success - Cypress was not finalized as of the open-enrollment end date established in Board Policy PG-3.201; and

**WHEREAS**, the Board of Directors desires to establish a reasonable open-enrollment application window and lottery date for the Thrive Center for Success - Cypress campus only for purposes of its initial enrollment for the 2026-2027 school year; and

**WHEREAS**, the Board of Directors approved an open-enrollment start date, an open-enrollment end date, and a lottery date for applications to attend Thrive Center for Success - Cypress campus for the 2026-2027 school year at a lawfully conducted Board meeting on May 15, 2026; and

**WHEREAS**, as directed by the TEA, the Board desires to revise its Admissions and Enrollment Policy in conformity with the amended policy attached hereto as **Exhibit A**; and

**WHEREAS**, the Board of Directors desires to modify by non-expansion amendment, the open-enrollment charter of Thrive Center for Success (CDN: 170802); and

**WHEREAS**, 19 Texas Administrative Code § 100.1035(a) states that a charter may be revised with the consent of the charter holder by written amendment approved by the commissioner of education; and

**NOW, THEREFORE** the Board, at a lawfully called meeting, held in compliance with the Texas Open Meetings Act, do hereby confirm and ratify the following actions taken and adopt the following Resolutions:

**BE IT HERBY RESOLVED THAT:**

- The amended Admissions and Enrollment Policy attached hereto as **Exhibit A** is approved.
- The Board approves, reaffirms, and ratifies that for applications to attend Thrive Center for Success - Cypress during the 2026-2027 school year only, as was approved by the Board at its May 15, 2026, Board meeting and as reflected in **Exhibit A**:
  - The open-enrollment start date shall be May 22, 2026, and the open-enrollment end date shall be June 5, 2026. The lottery will be held on the first Friday following the open-enrollment end date and deadline for submitting an application to attend Thrive Center for Success - Cypress for the 2026-2027 school year. The lottery shall be held on June 12, 2026.
- The open-enrollment application window and lottery date stated above may be revised by the Superintendent as required by TEA, subject to further Board approval or ratification.
- The Board of Directors authorizes and directs the Superintendent to establish and implement the open-enrollment application window and lottery date as stated above, or amend such dates as otherwise required by TEA, subject to further Board approval or ratification.
- The Superintendent, or designee, is authorized to submit a non-expansion amendment request to the Texas Education Agency consistent with the above resolutions, to be effective May 15, 2026, or other effective date thereafter as required by TEA.
